**REPORT:** Mr. Sunil Harman, Aviation Planning Division Director, presented the Strategic Airport Master Planning Study for 2015-2050 (Plan). He noted this forecast of passenger service, cargo and overall airport operations was required by the Federal Aviation Administration. Mr. Harman said that 50 percent of the Plan's cost was
